**RESOLUTION AUTHORIZING AN AWARD OF CONTRACTS PURSUANT TO A PUBLICLY ADVERTISED REQUEST FOR PROPOSALS (#17-YS-01) BY AND BETWEEN THE COUNTY OF CAMDEN (ONE STOP) AND VARIOUS APPROVED PROVIDERS FOR WORKFORCE INNOVATION AND OPPORTUNITY ACT (WIOA) OUT-OF-SCHOOL YOUTH SERVICES FOR THE PERIOD AUGUST 1, 2017 THROUGH JUNE 30, 2018, IN AN AMOUNT NOT TO EXCEED \$143,991.02. FUNDING IS CONTINGENT UPON PASSAGE OF CHAPTER 159 RESOLUTION**

WHEREAS, the Camden County Workforce Development Board (WDB), issued a Request For Proposals on May 16, 2017 for the Workforce Innovation and Opportunity Act (WIOA) Out-of-School Youth Services to various providers for the term beginning August 1, 2017 and ending June 30, 2018; and

WHEREAS, the WDB Bid Review Committee has reviewed the submitted bids and has recommended that the contracts listed below be awarded; and

WHEREAS, funding for this purpose is contingent upon the passage of a Chapter 159 resolution for this purpose; now, therefore,

BE IT RESOLVED by the Board of Chosen Freeholders of the County of Camden that, contingent upon the funding as described herein and in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-4.5, the proper County officials be and are hereby authorized to execute all documents necessary to consummate contracts with the contractors listed below:


