#### **WELCOME**

Carl Donato, Chair, called the meeting to order at 9:07 AM, and welcomed attendees to the December Quarterly Board of Trustees Meeting.

- Carl led the Pledge of Allegiance.
- Reverend Michael Williams gave the invocation.
- Welcome remarks were given by Margo Venable, Executive Dean for School, Community and Workforce Training at Camden County College.
- Meeting attendee introductions.

### **GUEST SPEAKER**

Carl provided a brief bio of the guest speaker, Mr. Poo Lin, Chief Director, NJDOL/Labor & Workforce Development

- Mr. Lin commented about his personal connection with Camden County and provided a PowerPoint presentation illustrating an overview of the Camden County One-Stop and its initiatives since he assumed his role in September, and his goals, which includes the following:
  - ➤ Adequate and Quality Staffing in One-Stop Career Centers
  - ➤ Automation of Virtual Service Center through SimpliGov
  - ➤ Canon Secure Print Project
    - Auto Replenishment of toner.
    - Eliminating the need for parts and service Requisitions.
    - Individual Badge/Card/Fob Access for accountability and cost sharing.
  - > Jobs for Veterans State Grant (JVSG) Cash Incentive Awards FFY24
    - In recognition of exemplary performance in providing exceptional service to veterans, NJDOL will provide cash incentives to three One-Stops that have outperformed their peers. The employees named on the award nomination application of the One-Stops receiving an incentive award will share in the overall office award. One-Stops are limited to one office-level incentive nomination per year. To be considered for an incentive award, the One-Stop and its employees must demonstrate excellence in providing quality services to veterans. Awards will be reserved for instances where most if not all, employees at the One-Stop contribute to improving services offered and provided to veterans. Awards will be granted based on a review of objective data and a subjective nomination, including quantitative and qualitative factors.
    - Individual incentive awards will be based on subjective nomination and objective data. Anyone can nominate an employee for an individual award; however, nominations must be submitted to the local ES Manager for a preliminary review and submission. ES Managers are responsible for reviewing individual nominations, so they are not eligible for individual incentive awards. The following employees are eligible for individual incentive awards:
      - o Disabled Veterans' Outreach Program (DVOP) specialists,
      - Local Veterans' Employment Representative (LVER) employees, otherwise known as VBRs, and

- Individuals providing employment, training, and placement services to veterans under the Workforce Innovation and Opportunity Act (WIOA), including labor exchanges funded by the Wagner-Peyser Act.
- o NJDOL Growth Mentorship Program
- Workforce Program Information Sessions
  - Short-term training goals
  - Monthly sessions
  - December 1, 2023 (1st) Session Topics
  - NJDOL's Leaning Management Systems (LMS)
  - Jersey Job Clubs (JJC)
  - Apprenticeships
  - Long-term programmatic goals in 2024
- In closing, Mr. Lin shared a personal story about his family and his upbringing in Camden County.

#### **REMARKS**

Commissioner Jonathan Young offered the following comments:

- There was an extra \$5 billion in rateables last year due to the growth in commercial and housing construction projects in Camden County.
- High schools, vocational schools and non-profits are creatively providing trades education options for students and others who will not attend college and are seeking training opportunities.
- He applauded American Training Center, which has 100% job placement and recently graduated 85 students who all have jobs.

#### ONE STOP CAREER CENTER SUCCESS STORY

Jeffrey Swartz, WDB Executive Director, introduced Jazzhonii Tillman, DVRS Counselor the Camden County One-Stop, to share a Success Story about their client, Samuel Schwartzberg.

Samuel applied for Project Search in February 2022 through YALE School. After completing the assessment and interviewing process, he was accepted into Project Search for the Fall 2022 school year. While in Project Search, Samuel went through 3 rotations (11 weeks each):

- The first rotation was guest services.
- The second rotation was food service.
- The third rotation was environmental services, storeroom, and patient transport.

Samuel graduated from high school and Project Search on June 7, 2023. Following graduation, he started working with Jewish Family Children Services, which assisted him with employment applications, preparing for interviews, learning the job duties and then being able to maintain a job.

On September 19, 2023, Janeene Martin, from JFCS Job Coach, helped Samuel obtain employment at Honeygrow in Cherry Hill as a food prep worker. She has helped Samuel learn his job duties, to ask for help when needed, and gain natural supports.

#### ONE STOP CAREER CENTER UPDATES

Frank Cirii, Local Area Director, Camden County Career Center

- The One-Stop has transitioned from being a Hi-SET testing site to a GED testing site.
- The SNAP/TANF customer flow and counseling program has been totally restructured. All SNAP/TANF customers are provided with an IEP and opportunities for integrated training and employment services.
- An educational outreach campaign in 2023 will be continued in the new year. Information will be shared via public transportation systems by a QR code that provided information about all of the services available at the One-Stop. A new WIN (WorkSource Information Notice) and TEGL (Training and Employment Guidance Letter) will provide funds expand outreach using more creative means.
- Post-Covid in-person job fairs were held in 2023:
  - Job fairs were held on March 3<sup>rd</sup> and September 15<sup>th</sup> at the Cherry Hill Mall.
  - A "Veterans Only" hiring event was held at Cooper Hospital in June.
- The first job fair of 2024 is scheduled for January 19th from 10:00 AM to 2:00 PM at the Cherry Hill Mall.
- In addition to ShopRite, the Incumbent Worker Training Program (IWT) added 2 new employers:
  - Bancroft (Pilot Program)
  - Goodwill
- The Youth Work Experience has expanded from 3 employers to 7 in various parts of the county. The objective is to fill the need for county youth participants to earn credentials and move forward with their skills to gain full time employment. Stipends are provided to the youth participants.

- Under Eric Romolini's leadership, the Fiscal Division has significantly updated the formats of fiscal reports and modernized methods of providing its reports to the Systems Performance Committee and the State.
- The MIS Division has received multiple NGOs from the DOL. Laurie McGuire and MIS staff processed and entered the following into the AOSOS system:
  - Pathways to Recovery (an Opiate grant)
  - SNAP Skills, Training, Employment, Program to Success (STEPS)
  - Judiciary Opportunities for Building Success
  - Bridges to Employing Youth
  - NJ Youth Corps
  - State On the Job Training Programs
  - Trade Adjustment Act
  - Opportunity Partnership
- South Jersey Transportation Authority continues to provide the TANF shuttle service to customers for access to the Board of Social Services, the One-Stop and Employment Services, which are centralized to the Woodcrest location.

Carl thanked everyone in attendance for their work on behalf of the people of Camden County and wished everyone happy holidays.
